## **5.1: Principal** (tabled by Lee A)

- Hosted 35 reception teachers as part of Catholic North West Region, which included a tour of the school
  - People were happy to stay, and feedback re school facilities, etc, was very positive.
  - Placed us on a level if not better playing field with other schools in the area.
- Significant improvement with student behaviour, regulation, restorative practices.
- Increased ESOs providing student support.
- 8/10 classes staffed by permanent teachers
- Literacy focus is strong InitiaLit, PLD, Steven Steps to Writing Success
- Growing school
- Started with 219 students
   2022 8 classes, 2023 9 classes, 2024 10 classes, same pattern of increase predicted up to 2028
- Principal's 2 year appraisal completed successfully
   Appointed now to 5 year tenure point
   At 7<sup>th</sup> year point, a final appraisal, after 10 years reapply or apply elsewhere.

#### **5.2: School Board Chairperson** (tabled by Simon C)

- Great year in 2023, thanking all especially the specialist teachers, Art, Drama, P and F
- Importance of volunteers, outside of the Board, including P & F, canteen, etc
- Capital improvements, achieved a lot, including courts, Nature Play areas

   219 students, organic growth, very happy to see the school community grow.
- Strongly encourage for the Board, and in general, for the school to support amazing work of the staff and students

- Whole school masses opportunity to come together as a community
- Mercy Day run by Year 6s, with \$1350 donated to Catholic Charities, as well as Catherine House, Socktober
- Finished year with Nativity story at Carols evening, facilitated by SRC,
- Years 6 Graduation and end of year liturgy

- Sources of income, including:
  - \$142k cash deficit, result of the capital works done in the school
  - \$269k was predicted so did well to come under that
  - Not in red just used money in the bank
- Able to deliver on project even though reducing school fees by \$200 to \$2200
   Fees stable for future
- Improvements listed by Diana
- In consultation with GGA architects re redevelopment of the new building, full steam ahead of detailed market plans
- Working on 10 year financial plan to support building proposal
- OSHC increased in numbers across the board.
- Excellent Parents and Friends year, \$13k
   Colour run, Quiz Night, Community Lottery
   go towards the student chilled water fountain
   Welcomed Josie S in the Canteen
   Increased orders on Friday up to 150

- Qkr! app ordering assisting with increased orders due to convenience
- Looking at using Qkr! app for sport payments and forms.
- Great year in finance this year, lot of work to come to get prepared for the build.
